Current Status

- ☛ 100+ countries have National ID Programs but Digital ID adoption is slow
- ☛ Several high profile programs have stalled or been abandoned
- ☛ 911 has revived political will
- ☛ Progress differs across regions
- ☛ Privacy and Civil Liberty issues depend on political/cultural factors

Regional Differences

☞ North America

- Threat of “Big Brother”, Privacy & Civil Liberties issues loom large, voluntary is key

☞ South America

- Mandatory participation to fight fraud

☞ Europe

- Privacy, Little Brother, culture supports programs

☞ Middle East & Africa

- Mandatory participation to fight fraud, rapid adoption

☞ Asia

- Aggressive pursuit in many nations, culture supports programs, mandatory & voluntary, rapid adoption

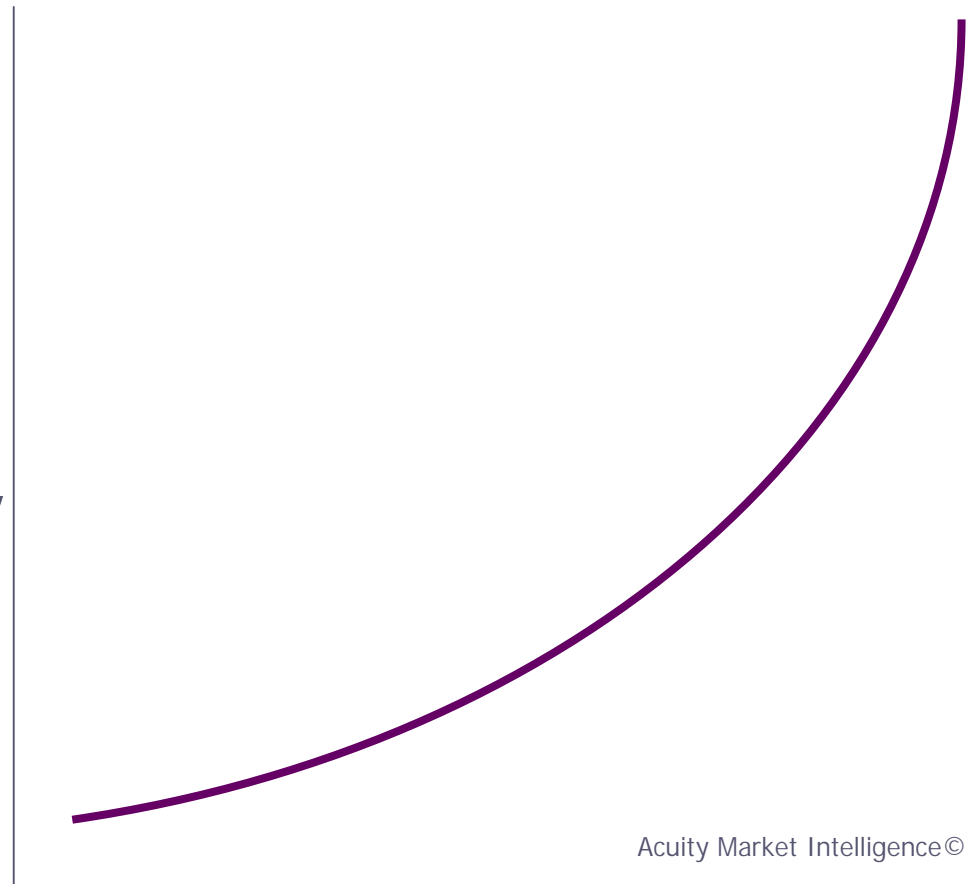
